Faculty Inputs on University of Mumbai, Bachelor in Pharmacy (B.Pharm) Syllabus: - 2023-24

In alignment with NAAC Criteria 1, feedback on the syllabus was solicited from the faculty for the academic year 2023-24. This report summarizes the inputs provided by the faculty concerning the design and review of the syllabus, with a particular emphasis on the examination scheme, course content, industry relevance, and overall curriculum structure. The key suggestions were forwarded to the school leadership for further consideration. The aim is to enhance the curriculum to better meet industry standards, incorporate recent advancements, and address educational gaps. The inputs have been categorized into suggestions for the design and review of the syllabus and suggestions for courses to be added. Feedback was collected from faculty members through Google Forms.

KEY ELEMENTS:-

1. Suggestions for Design and Review of Syllabus

- Incorporation of Recent FDA-Approved Drugs: It was suggested to add topics on recently FDA-approved drugs within the pharmacology course.
- WHO Global Health Days and Campaigns: Introducing the celebration of various WHO global health days and campaigns to the curriculum.
- Examination Scheme Adjustments: There was a recommendation to skip the MCQ pattern for courses related to chemical safety, food chemistry and regulations, retrosynthesis, and sustainable drug synthesis.
- Personalized Medicine: Including topics related to personalized medicine to keep up with current trends in the field.

- AI & Data Analytics: Given the importance of AI in healthcare, course can be designed on applications of AI in healthcare incorporating Data analytics
