**CODE OF CONDUCT: FACULTY & STAFF**

**1. All teachers and employees shall observe the following Code of Conduct namely:**

- (a) An employee shall treat all students without discrimination on political ground or for reasons of race, religion, caste, language or sex or any other reason of arbitrary or personal nature and shall refrain from instigating students against other students or other employees or institute administration or management.
- (b) A teacher shall not misuse the facilities of the institute while exercising freedom of academic thought or expression.
- (c) An employee shall not make use of the resources and facilities of the institution or Management for his personal use or for commercial, political or religious purposes.
- (d) A teacher shall be impartial in assessment of students and shall not deliberately over mark or under mark or victimize students on any ground.
- (e) A teacher shall not conduct or be employed in any private coaching classes or give private tuitions on commercial basis.
- (f) An employee shall communicate change in address, if any, during vacation or leave period to the Head of the department, Principal or Director as the case may be.
- (g) Full-time teaching staff shall not accept part-time employment on payment or for any consideration in another educational, cultural or literary institution without obtaining prior written permission from the authorities of the institute in which he/she is employed on full-time basis.
- (h) Faculty/staff should not misuse the institute property. Office mobile no/landline no for their personal use.
- (i) The behavior of an employee with male and female students and employees shall be modest.
- (j) An employee shall strictly abide by any law relating to intoxicating drinks or drugs in force in any area in which he may happen to be for the time being;
  - (ii) not consume any intoxicating drink or be under the influence of any intoxicating drink or drug, during the course of his duty; and shall also take due care that the performance of his duties at any time is not affected in any way by the influence of any such drink or drug.
  - (iii) refrain from consuming any intoxicating drink or drug in a public place;
  - (iv) not appear in a public place in a state of intoxication;

Explanation: For the purpose of this rule, "Public Place" means any place or premises (including conveyance) to which the public have or are permitted to have access whether on payment or otherwise.

**2. Failure to conform to any of the rule of Code of Conduct mentioned in sub rule shall be treated as an act of negligence or misconduct or both.**

- Students who do not show any improvement in academic progress despite all the support, found to be involved in substance abuse and refuse rehabilitation.
- Involvement in Sexual Harassment / eve teasing.
- Fail to complete programme of studies within the maximum time limit provided by the University of Mumbai.

The code governs all Schools of Anjuman-I-Islam's Kalsekar Technical Campus, New Panvel.

### **DRESS CODE FOR STUDENTS**

#### **A. DRESS CODE: MALE STUDENTS**

- ✓ Dress code is compulsory with formal/Sports/Canvas shoes and I-card on all working days as prescribed. **NO RELAXATION HENCE FORTH ON FRIDAYS, DURING CLASSES, EXAMINATIONS, TESTS OR OTHERWISE.**
- ✓ Single collared full sleeves **WHITE SHIRT** and Jeans/Trousers of **DARK BLUE/BLACK COLOR.**
- ✓ Formal / Sports / Canvas Shoes and Socks.
- ✓ Chappals / floaters / Sandals not allowed unless notified separately during Monsoon.
- ✓ Dress (other than prescribed) on special occasion (with prior permission) should only be formals.

#### **STRICTLY PROHIBITED (MINIMUM FINE OF RS.500/- FOR DEFAULTERS)**

- X No funky colorful Pants and Capri's allowed.
- X Skin tight Trousers/Jeans and T-Shirts (Round neck).
- X Low waist revealing clothes.

**Note: Dress (other than prescribed) on special occasion (with prior permission) should only be formals. Prohibited dresses are not allowed even on Special occasions.**

- X Garments with abusive, indecent, vague quotations etc.

## **B. DRESS CODE: FEMALE STUDENTS**

- ✓ Regular **WHITE LONG KURTA / KURTI / LONG DECENT SHIRT** with at least 3/4th sleeves to be worn on **DARK BLUE/BLACK COLOURED CHUDIDAR/JEANS**.  
(All Days during Classes, Examination, Test or Otherwise)
- ✓ If Chudidar is worn, it should be with a long Kurta.
- ✓ Decent Sandals/ Sports shoes/ formal women shoes to be worn.
- ✓ Those wearing Burkha throughout the day are exempted from specified dress code.
- ✓ Those with long hair/below shoulder length are expected to keep them tied preferably.

## **STRICTLY PROHIBITED (MINIMUM FINE OF RS.500/- FOR DEFAULTERS)**

- X No loose hairs.
- X Skin tight fitting clothes, skin tight leggings and Sleeveless garments.
- X Jeans, T-shirts and any other clothing resembling MALES.

*Note: Dress (other than prescribed) on special occasion (with prior permission) should only be decent formals. Prohibited dresses are not allowed even on Special occasions.*

## **STRICTLY PROHIBITED BEHAVIOUR (MINIMUM FINE OF RS.1000/- FOR DEFAULTERS)**

- X Quarreling / Fighting.
- X Shouting / Speaking loudly
- X Using Abusive / Slang Language.
- X Loitering / Roaming around, skipping TH/PR Sessions.
- X Intermingling and physical touching amongst BOYS and GIRLS
- X Trespassing faculty areas such as in canteen / washrooms etc.

## **USE OF MOBILE PHONES / TABS**

- X Use of Mobile Phones/Tabs strictly prohibited during lectures/ practical, within the class rooms/labs, in/out/around faculty rooms, offices, corridors and staircases of the campus.
- ✓ Use of mobile phones partially allowed (if necessary) in canteen, students pathways, lawn.
- X Anybody if caught using these gadgets in prohibited areas, it shall be seized and shall be returned to their parents only after the end of semester (with an Undertaking).

- ✓ A well appreciated distance should be maintained between Boys and Girls.

**Note:** Strict disciplinary action will be taken against those found not abiding by this Rule.

### **ABSENCE FROM ACADEMICS**

Late coming, Skipping theory/ Practical etc. and loitering / hanging out in canteen /Sports areas/ basement is highly discouraged and may lead to suspension/ detention/rustication.
